Viz:

1 On page 7, after line 11, add the following:

2 **SEC. 5. INVESTIGATION OF TERRORIST ATTACKS AGAINST**
 3 **THE UNITED STATES ATTRIBUTABLE TO THE**
 4 **GOVERNMENT OF MUAMMAR QADDAFI.**

5 (a) CONTINUING INVESTIGATION.—The President
 6 shall continue any investigative activities of any Federal
 7 agencies with regard to the bombing of Pan Am flight 103
 8 and any other terrorist attacks attributable to the govern-
 9 ment of Muammar Qaddafi against United States citizens,
 10 with the goal of determining the identities of the individ-

1 uals responsible for the attacks and bringing such individ-
2 uals to justice.

3 (b) REPORT.—

4 (1) IN GENERAL.—Not later than 180 days
5 after the date of the enactment of this joint resolu-
6 tion, and annually thereafter, the President shall
7 submit to Congress a report on investigative activi-
8 ties described in subsection (a), including the fol-
9 lowing elements:

10 (A) A description of efforts by the Presi-
11 dent to ascertain information through all avail-
12 able channels, including inquiries with members
13 of the Transitional National Council and any
14 successor government in Libya, about the
15 bombing of Pan Am flight 103 and other ter-
16 rorist attacks attributable to the government of
17 Muammar Qaddafi against United States citi-
18 zens, with the goal of determining the identities
19 of persons who have knowledge about such at-
20 tacks or were involved in the planning, execu-
21 tion, or cover-up of the attacks.

22 (B) An assessment of the cooperation of
23 the Transitional National Council and any suc-
24 cessor government in Libya in ascertaining such
25 information and in facilitating access to nec-

1 essary persons and documents related to the
2 bombing of Pan Am flight 103 and other ter-
3 rorist attacks attributable to the government of
4 Muammar Qaddafi against United States citi-
5 zens.

6 (2) FORM.—The report required under para-
7 graph (1) shall be unclassified, but may contain a
8 classified annex.

9 (c) COOPERATION.—

10 (1) IN GENERAL.—The President shall urge the
11 Transitional National Council and any successor
12 government of Libya to cooperate with and partici-
13 pate in the investigative activities described in sub-
14 section (a).

15 (2) CONSIDERATION OF COOPERATION IN CER-
16 TAIN FUTURE DECISIONS.—The President shall con-
17 sider the cooperation by the Transitional National
18 Council and any successor government of Libya with
19 respect to the investigative activities described in
20 subsection (a) when making decisions about the dis-
21 tribution of confiscated property and the provision of
22 United States assistance to the successor govern-
23 ment.
