The existing bikeway west of Somerville Road serves the 1886 homes of the Hills Condominiums complex, with a population of more than 5,000 residents.

The final result of this renovation project will be to create a more attractive, home-like setting for children and adolescents who have experienced chronic trauma in their short lives.

An estimated 1,500 linear feet of concrete walkways will be replaced with a four foot wide brick "paver" walkway. Deteriorated curbs and sidewalks will be constructed, ADA accessible ramps and detectable warning surfaces will be installed at all intersections, and street plantings will be installed. The

project will improve safety for motorists and pedestrians, especially the elderly, improve traffic flow, reduce congestion and emissions and improve air quality and support economic revitalization of Avenue C.
